OLD TITLE: AGG ARSON - FAILURE TO DISMISE / RTR

The following information is offered as a supplemental report for the arrest that took place on 7-20-2016 on E. 4 and Prospect by law enforcement members assigned to the RNC.

Open Source information was forwarded to officers working the crowd management detail warning that members of a group that identified themselves as "rev.com" were advertising a flag burning to take place at E.4th and Prospect at 1600 hours. Copies of this were printed from the internet and are available for prosecution.

When members of this group arrived on E. 4th and began walking from Euclid to Prospect, Cleveland Police immediately began to follow the group.....

Open flames and burning of any sort were deemed prohibited by the City of Cleveland in the RNC event zone. This fact along with a list of several other prohibited items was published and announced by the City via several media outlets to the general public.

The group formed a circle at E.4 and Prospect. JOHNSON and CASTANON were in the center of the group. As soon as they began to light an American flag on fire, Lt Gaertner and Sgt William Stanton used "cold fire" to extinguish the flame. Several members of the rev.com group attempted to restrict their access as they were doing this. Two civilian media members were burned as the result of the recklessness of JOHNSON and CASTANON. Additionally two unidentified members of the group protesting were also caught on fire by the flag burning.

JOHNSON and CASANON were continuously before during and after calling for the other throw of the government during their arrests inciting the crowd to commit other acts of violence.

REQUEST PACE ALSON FOLLOW UP.

Several of these acts were captured on different media and will be available for prosecution.
